## From the Executive Director

Dear colleagues and friends,

Welcome to our first newsletter of 2026, and there is plenty to share with you. Please continue to share this email with colleagues and chapter members who might find elements of interest.

You will receive this email on the day that myself and others, most notably the team from Wakefield Cathedral will be attending the funeral of Rachel Copley, Wakefield Cathedral's COO who sadly died just after Christmas. I knew Rachel to be a really enthusiastic and generous contributor to the wider network; Wakefield Cathedral have lost a gifted colleague and a warm friend, and I'll be honoured to represent the wider Cathedral network, particularly Rachel's CAFA colleagues today.

Last week I had the pleasure of attending the Cathedrals Plus conference in Dublin, and for the first time visiting two of our member Cathedrals; Christ Church Cathedral and St Patrick's Cathedral. Two Anglican Cathedrals within a mile of each other in a country where only 2% identify as Anglican. Their work is a testament to partnership, community and with a heart for the people of the city. We learnt that the Cathedrals collectively feel they contribute to the 'Soul and Stones of the City' and the generous Dublin welcome was certainly soulful. I was delighted to share time with colleagues in education, learning, outreach and visitor engagement - what an enthusiastic and engaged group of people!

Today we also received news of the government's new £92 million Places of Renewal Scheme. You can read more here: <https://ow.ly/9eST50Y1zCQ>. It is still too early to know the finer details of the fund, or how it will benefit our sector in comparison to the LPWG Scheme which it replaces. Our fine colleagues in the Cathedral and Church Buildings Team have campaigned alongside others for support to replace LPWG Scheme, and they are to be applauded for their advocacy and consistency.

## 2. Vacancies and Appointments

### Appointments:

**Hereford Cathedral** is pleased to announce that Andrew Reid will become the cathedral's new Director of Music following the retirement of Geraint Bowen. Andrew will also hold the position of Conductor of Hereford Choral Society and Artistic Director of the Hereford Three Choirs Festival, and will be responsible for programming the 300th edition in 2028.

Prior to his current position, Andrew was Managing Director of Harrison & Harrison Organ Builders (2017–22) and also Director of the Royal School of Church Music. He worked in cathedral music between 1996 and 2012 as Director of Music at Peterborough Cathedral, Sub Organist of Westminster Abbey, and Assistant Master of Music at Westminster Cathedral. In the latter two positions he played for the funerals of HM Queen Elizabeth the Queen Mother and Cardinal Basil Hume and accompanied various critically acclaimed recordings on the Hyperion label. While in Peterborough he directed the Northampton Bach Choir and instigated choral and orchestral concerts in the cathedral.

Andrew is originally from Kent and educated at Cambridge. He is married to Louise, and they have four children, who have all been cathedral choristers. He also once performed the complete organ works of JS Bach in a single 25-hour recital!

**Guildford Cathedral** announced on Wednesday that Katherine Dienes-Williams, their Organist and Master of the Choristers, has been appointed Director of Music at **Winchester Cathedral**.

The Dean of Guildford, the Very Reverend Bob Cooper, said: "We offer Katherine our warmest congratulations on this wonderful appointment. Winchester is gaining a truly gifted musician and an inspiring leader. Whilst she will be deeply missed by all of us at Guildford, we send her with our heartfelt thanks for everything she has given to this cathedral community and our prayers for this exciting new chapter in her ministry."
